Dear Parents,

The Howitt Staff and I would like to welcome you and your children to the Farmingdale Youth Council 2018 Summer Recreation Program. In order to operate a safe and successful program, the staff asks that all parents and participants in our program adhere to the following.

- 1. The 2017 Summer Program begins on **Monday, June 25, 2018** and concludes on **Friday, July 27, 2018**.
  - Parents dropping off and picking up children by car <u>must</u> enter through the Grant Avenue driveway and exit via the Cherry Street driveway.
    - \* WHEN DROPPING OFF AND PICKING UP, WE REMIND EVERYONE TO PLEASE BE AWARE OF WALKERS.
  - Rec. starts at 9:30 A.M. No children will be permitted to enter the building before this time.
  - Dismissal will begin at 1:20 PM. Please be prompt.
  - Everyone is to enter and exit the building through the doors located on the side of the West Building near the Gymnasium. (*Parents / Guardians should report to the Summer Program Office.*)
  - Crossing Guards will be located at the intersection of Staples Street and Route 109 (Fulton Street) and the intersection of Cherry Street and Conklin Street.
    (Please notify our Office if your child is a bike rider or walker.)
  - All bicycles should be securely chained and locked. No bicycles will be permitted in the building.
  - <u>PLEASE NOTE</u> Due to Summer Trips and Special Events, it may be necessary at times to alter the program hours. In such instances, these hours will be noted on the activity's flyer.
- 2. Appropriate behavior of all participants is expected at all times.
  - Participants are not to open or disturb Teacher's Desks, closets, supplies, personal belongings or any other contents of the areas that are used by the Summer Program.
  - Participants are to remain with their assigned groups at all times.
  - Running in the halls, sitting on windowsills, and sitting on desks or tables are not allowed.
  - Roughhousing, fighting, abusive language, and bullying will not be tolerated. (And may result in dismissal from program.)
  - For safety reasons, all participants **<u>must</u>** wear sneakers (<u>no wheels</u>) every day and participants should not wear any jewelry to the program.
  - Participants are not to bring cell phones, games, toys, or other valuables to the program. The Summer Program cannot assume responsibility if any personal items are lost, broken, or stolen.

- 3. Snack time is built into our daily schedule. Participants should bring a snack/drink with their name clearly labeled on it. (Glass bottles and fan water bottles are not permitted.)
- 4. Only Cash and Money Orders will be accepted as payment for trips and special events.
- 5. If it is necessary for your child to be dismissed early, please contact our office so that arrangements can be made. Only a parent / guardian with proper photo id will be allowed to pick up a child before dismissal unless we are notified in advance.
- 6. If your child has an allergy or other medical condition that we should be aware of, please notify us as soon as possible.

## CELL PHONES
